A. Call to Order

Chair Pelletier called the regular meeting to order at 6:38pm

C. Recognitions

- 1. Would like to commend Cassy and Adam Moshier of Taco Beyondo, Ed Whiting of E.K.W Painting & Texture, Local massage therapist Sue McFee, Arcom Communications, and many Beyondo parents
 - 1. Presented two Checks totaling 1447.60 to food services to help pay off the unpaid balances for 66 families.

D. Correspondence

- 1. Mr. Peterson Brookside Middle School Texas
 - a. Sent an email thanking the middle school for sending a care package in the mail that included mementos from the Hillsboro Middle School and surrounding area, as well as a \$350 Amazon gift card. The care package was something the middle school students raised money for to help with hurricane disaster relief.

E. Presentation

- 1. Elementary Math Program Pilot Dan Record
 - a. The current math program being used is called Invisions, which was created in 2010.
 - b. He feels this program is not addressing today's math needs.
 - c. The goal is to have all students algebra ready by high school.
 - d. Want to move our students from the bottom score range to the mid score range within the next few years.
 - e. Moving forward, our students will be more prepared to take higher level math courses.

- f. The plan
 - i. A newer program has more rigor, and depth of knowledge. It teaches math for kids to really understand math.
 - ii. Researching three potential new math programs
 - 1. EnVision
 - 2. Eureka
 - 3. Bridges
 - iii. They plan to pull several units from each program and try them out throughout the year and look at the different components from each program.
 - 1. Will have different grades and teachers trying these units.
 - iv. The new program will cover grades K-5.
- g. Changing over to a new math program is not a magic fix, but a process that will take time to see results. There will be growing pains for the first year or two, but after that confidence is gained along with notable progress.
- h. The programs also include professional development for teachers
- i. Some of these programs also include a parent portal online.
- 2. Questions
 - a. Paul Plater
 - i. Does this allow for more, or less homework?
 - 1. In the beginning there will be less homework
 - a. We do not want to overwhelm families with a different type of homework.
 - 2. The homework will be different not less
 - b. Steve Hahn
 - i. We have been using the term "new math" for over 50 years. Is this because teachers won't give up worksheets?
 - 1. The difference in these new programs is the understanding piece.
 - a. These methods teach why we do something
 - b. Adds rigor, or different levels of understanding and depth of knowledge.
 - c. Chris Bober
 - i. Are there assessments to go with the programs, or benchmarks to measure progress?
 - 1. The programs come with their own assessments
 - 2. The current district tests will be the best benchmark tool to measure progress.
 - 3. There is no one program that covers everything.
 - d. Robert Hassett
 - i. How much of the \$37,000 is allocated to tech vs. physical materials? What's the ratio?
 - 1. Eureka has more tech for teachers at this point, but tech can be easily added to the program.
 - 2. Everything in the program is supplemented by technology.
 - 3. It is more hands on at the elementary level use of manipulatives.

- ii. What is the timeline?
 - 1. This year research in spring (April/May)
- iii. We may find out we need more professional development
 - 1. Could purchase next year to use the following year.

- i. Initial cost for technology, books and materials.
 - 1. Consumable costs?
 - 2. Some: workbooks.
 - 3. Some schools contract out their printing costs. Looking @ options.
- ii. Percentage of how much is available online?
 - 1. Don't have that number. The majority is paper and pencil.

 - a. Thank the board for the level of tentative funding of FTES.
 - i. The number one thing is to maintain low class sizes with quality teachers.
 - ii. Appreciate the preservation of FTES for next year.

- a. Skeptical about new math programs
 - i. The numbers are still the same
 - ii. Manipulatives work the same (plastic blocks vs pennies)
 - 1. They are used to get the kids to think about the numbers
- b. Hope that the new math program makes a difference if the district decides to do it.
- c. Take your time to research it before you spend our money.
- d. Class sizes
 - i. Questions how much a small class size makes a difference.
 - ii. Present the data on how small class size impacts learning.

3. Kelly Seymour

- a. Supports smaller class sizes in general
 - i. We need to keep standards on classroom behavior
 - ii. Can't let a few students take away from the rest of the class
 - iii. Parent input: daughter does not understand the new math
 - iv. Does not think the parents in this district will use the parent portal

 - i. Speak with Principals about behavior while teachers are working with difficult children.

 - a. We as a board have been concerned with math testing.
 - i. Calling for changes in the math program
 - b. Let's move forward.

 - a. STAR 360 multiple assessment throughout the year to measure growth.i. Not as high stakes.
 - b. We can't teach to the middle
 - i. Need to teach each student individually
- 5. Plater
 - a. Eureka is pre-k to 5.
 - b. STAR 360 tests which grades?
 - i. Can be done in Kindergarten through fifth grade.
 - c. Chromebooks + iPads are in grade 2-5

 - a. Pre-K through fifth grade are interesting grades to try to assess.

 - i. She isolated all of the salary lines, and multiplied that total by .0765 FICA rate
 - a) \$10,682,000 total was within \$4,800 of what it should be.
 - b. Asked on data on replacing vans
 - i. Current vans are 2009/2011 vehicles
 - ii. Both have under 30k miles Doesn't feel they should be put in the budget at this time.
 - a) Possible trust fund for future replacement
 - b) Consider a warrant article to establish trust fund to accumulate \$25k to replace in future.
 - c. Warrant article to replace the pick-up truck
 - i. 110,000 miles on the current truck.
 - a) Feels there is a sense of urgency to replace this truck.
 - d. Tuition for students
 - i. HS \$17,166.00/student
 - ii. Tuition rates are dictated by the RSA average cost per student/per year based on previous year.
 - a) Elementary rate \$16,605
 - b) Middle school \$14,972
 - c) High school \$19,702
 - iii. Washington Agreement (Currently have 39 HS, 32 MS students)
 - a) Middle school calculated by a formula
 - 1) \$19,892/per student based on proposed budget

- i. \$17,599.00 based on actual expenses
 - b) Windsor (Currently have 6 HS, 5 MS, 8 Elementary students)
 - 1) Elementary \$16,605
 - 2) Middle -\$14,972
 - 3) High \$19,702
 - c) Total income from the three different districts almost \$4.7 Million.
- e. Trust Fund Balances
 - i. Allocate interest 2 times a year, the packet has an estimate of where the balances are at.
- f. Question by Paul Plater
 - i. Why is there an increase of \$37,000 in the Elementary Teaching Salaries?
 - a) The increase is teaching salaries vary between different schools
 - 1) based on retirement numbers
 - 2) Numbers are based on turnover, and are not predictable.
- g. The board asked Lori to pull the line item for the replacement vehicle from the budget
 - i. Historically we have not included vehicles in the budget they are warrant article items.
- h. Salaries for extracurricular activities
 - i. Compared our current salaries to other schools with similar programs.
 - a) the proposed budget reflects the adjustments to bring them to more appropriate levels.
 - 1) Around \$18,000
 - ii. Adjustments are typically made outside of the typical contract
 - a) Can present job descriptions of each extracurricular activity.
 - iii. It's very hard to put a price tag on the impact that these programs have on kids' lives.

 - a) Anticipated revision? Factor in retained balance?1) No

 - a) McDonalds has expressed interest in their plans to support fundraising efforts in playground

 - c) Bottom line, urge board to put forward a warrant article that includes all 3 phases as one project saves money


