## I. School Board Response to Public Comment

Rich asked if this was Route 68 and was told yes. Jean said Bus 68 has reached capacity, and is the only 4 wheel drive bus. The route is determined by the geography. The Superintendent said adding another would cost be about \$40k.

3 of the 8 buses are currently running at capacity. Paul asked how many Deering students there were.

The Superintendent and Jean will meet with the bus company to discuss this further.

## K. Superintendent's Report

The opening of school was incredible. Hats off to all staff, especially maintenance. Many people felt this was the smoothest opening in a long time, and the credit goes to the building principals.
