

SCHOOL GOVERNMENT

The towns of Deering and Hillsboro belong to a cooperative school district. All the school buildings are located in the town of Hillsboro with the exception of the High School Alternative Program located in Deering. This District is called the Hillsboro-Deering Cooperative School District. All schools in the cooperative are governed by the Hillsboro-Deering School Board. Windsor sends their students to Hillsboro-Deering schools under an area tuition agreement. Washington tuitions students to the HD Middle and High Schools.

WHAT IS SAU#34?

The school districts of Hillsboro-Deering, Washington and Windsor are a part of School Administrative Unit (SAU) #34 which serves as a "business front office" to handle all operational, business, and human resource functions of the school districts and to support a quality education for all students.

WHAT IS THE SCHOOL BOARD?

The school board is made up of elected citizens, with elections taking place the second Tuesday in March on the official school district ballot. To become a candidate for school board or moderator, one must file at the SAU office in Hillsboro. The Hillsboro-Deering School Board includes five members, one from Deering, two from Hillsboro and two at large, serving staggered three year terms.

WHAT DOES THE SCHOOL BOARD DO?

The Hillsboro-Deering School Board is primarily responsible for determining policy for the operation of the schools – including curriculum, finances, and operations. The school board develops and monitors a budget each year.

WHEN DOES THE HDSB MEET?

The Hillsboro-Deering School Board meets on the first and third Monday of each month, except during the budget season when meetings are held more often. Meetings are usually held at the HD Elementary School. All meetings are open to the public.

WHAT IS SB2?

In 1995, the NH Legislature passed what is popularly known, after the Senate bill that engendered it, as "SB2". SB2, codified as RSA 40:13, permits both towns and/or school districts to adopt "the official ballot for voting on all issues before the voters" at the same time they elect local officials. Adoption of SB2 requires a 3/5 majority vote at the polls. Similarly, after a town or school district adopts SB2, a 3/5 majority is needed to rescind it.

The towns of Hillsboro and Deering have adopted for their schools the Official Ballot Referenda, SB2, which utilizes the official ballot for voting on all issues before the voters. Under SB2, the annual town meeting, a meeting of citizens who come together to form a legislative body of the town, is divided into two sessions that are held about a month apart.

THE FIRST SESSION OF SB2

The first session, also referred to as the **DELIBERATIVE SESSION**, held annually in February consists of an explanation, discussion, and debate of each warrant article (or proposed ballot question) including the school district budget. The discussions held at this session are an important part of the process for voters to listen to a variety of viewpoints about what will be voted on in the second session voting held in Deering and Hillsboro in March.

MORE ON THE DELIBERATIVE SESSION

The DELIBERATIVE SESSION is similar in many ways to the traditional TOWN MEETING. But unlike town meeting, no final voting on warrant articles occurs at the DELIBERATIVE SESSION. However, registered voters of Hillsboro and Deering are allowed to make motions to amend the content, including dollar amounts of warrant articles whose wording is not prescribed by law. Seconded motions are discussed and then called to a vote. If passed, the amended wording of the warrant article appears on the official ballot for voting in March. Public participation at the DELIBERATIVE SESSION is important because of the potential impact on the final wording of the ballot questions.

THE SECOND SESSION OF SB2

The second session is held on the second Tuesday in March. At this second session, the school district voters, by official ballot, elect the school board member(s) and moderator and vote on all warrant articles including the school budget from the first session and questions required by law.
