Discussion; Question Can you give us more detail about what this is about. We have a trust fund because sometimes kids move into town that we did not budget for. We try to keep our budget as close to real as possible. Right now the balance is almost \$100,000 that does not cover many new students. We can not keep more than 2.5% of the current fiscal year in the account. If we have more than that up to \$30,000. Can be moved into the trust fund before the town receives a refund of the excess monies. When we budget now we try to budget for what we call ghost that is a few extra students. We need to get the balance up because if somebody moves in with 7-8 kids we are sunk.
