- b. Superintendent's Report
  - i. General Information
    - 1. Thank you to the Washington Police for helping support the school and showing a presence in December.
    - 2. Potential for remote learning we have had a lot of students out in the past week due to Covid.
      - a. If we have a need to go remote, we can do so with a targeted approach (per grade) for a limited amount of time.
      - b. The school would have to make accommodations for students who do not have covid, and the parents are not able to find childcare.
    - 3. There is an upcoming talk from the NH School Funding Fairness Project that will present and educate on how the funding works for NH schools, and how the taxpayers are affected.
      - a. We hope to have a session be held in Hillsborough, but there are other opportunities around the state to get this information.
  - ii. Pandemic Response Mitigation Decision Matrix Update
    - 1. See attached Sheets.
    - 2. There has been an update to the NH guidance for isolation and quarantine, but the school information has not been updated yet. This information will be coming in the next few weeks from DHHS.

  - iv. Mills will go back to the conservation commission and discuss further with them.
  - v. At the next meeting we will make our decision based on the recommendations that are brought back.
